General Comments

The judges were happy with how things went and the size of the show allowed them to take extra time to talk to exhibitors as well as to demonstrate various good qualities, faults, and disqualifications.

On the whole, it was a very successful show.

Take-Aways for the Next Show

We did not make a profit on this show, but personally, I think we are better off doing fundraising to support shows like this rather than trying to make shows pay for themselves.

As we were all either new to shows, or hadn't run a show in a long time, we did not pay enough attention to getting sponsors and donations for the show. We also did not pay enough attention to getting help with funding for ribbons, accommodation, and meals.

For future Youth Shows, we should be sure to have some kind of award that can be given to every exhibitor ("Longest Ears", "Cutest Face", "Most Colours", etc.)

I would also like us to form a formal Show Committee for each show with specific individuals responsible for the following:

- **Show Superintendent** (general management before, during & after show)
- **Show Secretary** (sanctions, entries, official ARBA records & reports, show program)
- **Show Steward** (show day announcements, getting rabbits to the table, arranging clerks, etc.)
- **Show Treasurer** (all show-related income & expenses - normally same as Club Treasurer)
- **Equipment Supervisor** (show equipment maintenance, getting to & from show)
- **Fund-Raising Manager** (getting sponsors, donations, etc.)
- **Judge Liaison** (booking judges, arranging transportation, accommodation)

These do not need to be assigned to different people, but each role should be well defined so people know what they are and are not responsible for.
